DUTIES AND RESPONSIBILITIES:

The Georgia Crime Information Center (GCIC) is responsible for the preparation and completion of audit reports which contain findings, evaluations, and recommendations for necessary correction action in accordance with the Rules of the GCIC Council, other relevant Georgia code sections and pertinent federal statutes and regulations. The position requires knowledge of state and federal laws, as well as, rules and regulations governing criminal justice information.

Compliance Auditor 1 or 2 will conduct triennial onsite and electronic audits of criminal justice agencies that access state and federal criminal justice information for either criminal justice purposes or authorized employment/licensing suitability determinations. Develops and presents training interventions to assist with compliance. The Compliance Auditor 2 acts as a lead worker and prepares advisories for upper management and assists in audit program revisions, as required.

Note: This position involves extensive travel throughout the State of Georgia. Compliance Auditor 2 – 40419 – pay grade 15

Completion of a bachelors' degree from an accredited college or university **AND** Twelve months of experience at the lower level (RCP101).

OR

Four years of experience at a level equivalent to a compliance auditor.
